ORDER OF ELECTION IN DISTRICT NO.2 AND NO.4 DIRECTORS

IT IS ORDERED THAT:

Section 1. Election Order. An election is hereby ordered to be held on Saturday, May 7, 2005 for electing a director in No.2 and No.4 single-member districts drawn by the Board of Directors for electing directors.

Section 2. Election Precincts and Polling Places. There shall be two election precincts for the election. The polling places for such election precincts shall be as follows:

**District 2: Sunset Canyon Baptist Church
 4000 Highway 290E
 Dripping Springs, TX 78620**

**District 4: Woodcreek City Hall
 41 Champion Blvd.
 Woodcreek, TX 78676**

The polls shall remain open on the day of the election from 7:00 a.m. to 7:00 p.m.

Section 3. Election Officers. The election officers for such election shall be an election judge and two election clerks at each polling place.

Section 4. Early Voting. **Joyce Cowan** is hereby appointed Early Voting Clerk. The Early Voting for the above designated election shall be at Early Voting Polling Places:

These places of Early Voting shall remain open for Early Voting for at least eight hours on each day that is not a Saturday, a Sunday, or an official holiday, beginning on the 20th day of April, 2005, and continuing through the 3rd day of May, 2005, and may remain open on one or more Saturdays during that period.

The early voting by ballot shall be conducted in accordance with applicable provisions of the Texas Election Code. The address of **P. O. Box 907, San Marcos, Texas 78667-0907** shall be the early voting clerk's mailing address to which ballot applications and voted ballots by mail may be sent.

Section 5. Ballots. That it is hereby determined that paper ballots shall be utilized in connection with the election for all early voting as well as for all precinct voting conducted on Election Day and that said ballots shall be prepared in conformity with the Texas Election Code and the Texas Water Code.

Section 6. Notice of Election. That notice of said election, including a Spanish translation thereof, shall be published at least one time in at least one newspaper with general circulation within the boundaries of the proposed district before the 30th day preceding the date of the election. Publication shall occur before or on April 7, 2004, as required by the Texas Water Code and shall be given in accordance with the terms and provisions of the Texas Election Code.

Section 7. General. Said election shall be held in accordance with the Texas Election Code, and only resident qualified voters within the boundaries of the Hays Trinity Groundwater Conservation District shall be eligible to vote in Single Member Districts No.2 and No.4 at said election. The presiding officer is hereby authorized and instructed to provide and furnish all necessary election supplies to conduct said election. Immediately after the election, the presiding judge of each polling place shall deliver the returns of the election to the temporary board, and the board shall canvass the returns and declare the result.
