# AMENDED ORDER OF ELECTION FOR DIRECTORS IN SINGLE-MEMBER DISTRICTS NO. 1, NO. 3 AND NO. 5

#### IT IS ORDERED THAT:

<u>Section 1. Election Order.</u> An election is hereby ordered to be held on Saturday, May 13, 2006, for electing a director in No.1, No. 3 and No. 5 single-member districts drawn by the Board of Directors for electing directors.

<u>Section 2. Election Precincts and Polling Places.</u> There shall be three election precincts for the election, coterminous with the same numbered single-member district. The polling places for such election precincts shall be as follows:

District 1: Dripping Springs Independent School District Administration Office

**District 3: Driftwood Community Center**

The polls shall remain open on the day of the election from 7:00 a.m. to 7:00 p.m.

<u>Section 3. Election Officers.</u> The election officers for such election shall be an election judge and two election clerks at each polling place.

<u>Section 4. Early Voting</u>. Joyce Cowan is hereby appointed Early Voting Clerk. The Early Voting for the above designated election shall be at Early Voting Polling Places:

These places of Early Voting shall remain open for Early Voting for at least eight hours on each day that is not a Saturday, a Sunday, or an official holiday, beginning on the 1<sup>st</sup> day of May, 2006, and continuing through the 9<sup>th</sup> day of May, 2006.

The early voting by ballot shall be conducted in accordance with applicable provisions of the Texas Election Code. The address of P. O. Box 1648, Dripping Springs, Texas 78620 shall be the early voting clerk's mailing address to which ballot applications and voted ballots by mail may be sent.

<u>Section 5. Ballots.</u> Ballots utilized in connection with the election for all early voting as well as for all voting conducted on election day shall be prepared in conformity with the Texas Election Code and the Texas Water Code and applicable federal law.

<u>Section 6. Notice of Election.</u> Notice of said election, including a Spanish translation thereof, shall be published at least once in a newspaper of general circulation in the District between April 13 and May 3, 2006, and shall be given in accordance with the terms and provisions of the Texas Election Code. Notice shall also be provided to the Hays County Clerk and posted at the early voting polling place, as required by the Texas Election Code.

<u>Section 7. Joint Election.</u> The election shall be administered as a Joint Election as authorized under Texas Election Code § 271.002 to include one or more of the following entities: Dripping Springs Independent School District, City of Dripping Springs, Village of Wimberley, and Hays Consolidated Independent School District.

Section 8. General. Said election shall be held in accordance with the Texas Election Code, and only resident qualified voters within the boundaries of the Hays Trinity Groundwater Conservation District shall be eligible to vote at said election. Only resident qualified voters of the District, in their respective single-member districts, shall be entitled to vote in the election for candidates for the director positions at issue in their respective single-member districts.

The presiding officer is hereby authorized and instructed to provide and furnish all necessary election supplies to conduct said election.

Immediately after the election, the presiding judge of each polling place shall deliver the returns of the election to the board, and the board shall canvass the returns and declare the result.
