**ORDER OF ELECTION FOR DIRECTORS
IN SINGLE-MEMBER DISTRICTS**

On this 4th day of August 2022, the Board of Directors of Hays Trinity Groundwater Conservation District convened in regular session, open to the public, with the following members Present: Linda Kaye Rogers, John Worrall, Toby Shelton, Holly Fults, & Doc Jones.

Constituting a quorum, and among other proceedings had by the Board of Directors was the following:

WHEREAS, the terms of office of members of the Board of Directors of this groundwater conservation district, will expire on December 1, 2022; and

WHEREAS, it is necessary for the Board to pass an order establishing the procedures for filing and for conducting said director election:

THEREFORE, BE IT ORDERED THAT:

Section 1. An Election be held on Tuesday, November 8, 2022, for electing single-member districts drawn by Allison, Bass & Magee, L.L.P. Attorneys at Law, and approved by the Board of Directors for electing directors.

Section 2. All requests by candidates to have their **NAMES PLACED UPON THE BALLOT** for the above-mentioned election shall be in writing and signed by the candidates and filed with the Elections Officer of the Hays Trinity Groundwater Conservation District no earlier than 8 AM, July 23, 2022 and no later than 5 PM, August 22, 2022.

Section 3. Jennifer Doinoff is Hays County Early Voting Clerk.

The early voting by ballot shall be conducted in accordance with applicable provisions of the Texas Election Code. The address of 712 South Stagecoach Trail, Suite 1012, San Marcos, TX 78666-6294 shall be the early voting clerk's mailing address to which ballots by mail applications and voted ballots by mail may be sent. Applications for Ballots by Mail must be received no later than the close of business on October 28, 2022.

Section 4. Ballots utilized in connection with the election for all early voting as well as for all voting conducted on Election Day shall be prepared in conformity with the Texas Election Code and the Texas Water Code and applicable federal law.

Section 5. Notice of said election, including a Spanish translation thereof, shall be published at least once in a newspaper of general circulation in the District between October 4 and October 13, 2022, and shall be given in accordance with the terms and provisions of the Texas Election Code. Notice shall also be provided to the Hays County Clerk and posted at the early voting polling place, as required by the Texas Election Code.

Section 6. The election shall be administered as a Joint Election as authorized under Texas Election Code § 271.002.

Section 7. Said election shall be held in accordance with the Texas Election Code, and only resident qualified voters within the boundaries of the Hays Trinity Groundwater Conservation District shall be eligible to vote at said election. Only resident qualified voters of the District, in their respective single-member districts, shall be entitled to vote in the election for candidates for the director positions at issue in their respective single-member districts.

The presiding officer is hereby authorized and instructed to provide and furnish all necessary election supplies to conduct said election.

Immediately after the election, the presiding judge of each polling place shall deliver the returns of the election to the board, and the board shall canvass the returns and declare the result.
